- 1. This is with reference to letter on the subject mentioned above.  - (iii) In case due to exigencies or other unforeseen circumstances if PWP wants to extend bandwidth through Air Fiber/ RF then nothing extra will be paid to the PWP. Permission for provisioning through Air Fiber/ RF will be subject to consent of customer.
 - (iv) Reports for performance, monitoring/usage, downtime to be submitted on monthly basis or as per requirement of Panchayati Raj Department.
 - (v) The facility of user/password level restrictions (Whitelisting of MAC ID) to prevent abuse.
 - (vi) Dedicated help desk of the PWP for resolving issues immediately.
 - (vii) Ensuring all the regulations and license condition of TRAI/DOT issued time to time.
 - (viii) Installation and Rectification team for providing technical support.
 - (ix) The work for installation may be completed within 03 months of the issue date of the work order.
 - (x) PWP may visit the site to acquaint himself with site conditions.
- 5. The work is to be carried out by the PWP partner on revenue share percentage for Model-III partners as applicable for EPWP plans under PWP Wi-Fi Open policy.
- 6. SLA is to be maintained as per requirement of Panchayati Raj Department. In absence of any SLA from Panchayati Raj Department, PWP has to maintain network availability of 99%.
- 7. The work should be completed in the stipulated time and given milestone should be achieved. LD will be levied as per norms of Panchayati Raj Department for any delay in start of service.
