



**!! REVISED !!**

On recommendation of rent revision committee for P & T Community Hall, Kidwaipuri, Patna, the Chief General Manager Telecom, BSNL, Bihar Circle, Patna is pleased to approve the revised rate for booking of hall, security deposit, electric charge and campus cleaning charge. The following revised rates will be applicable with immediate effect.

| SI. No | Category of Booking   | Booking charge per Day in Rs. | Other charges, cleaning / maintenance per day |
|--------|---|-------------------------------|---|
| 1      | Booking by working as well as retired employees of BSNL for their personal function & any ceremonial function of their sons, daughters, father & mother | 7,000/-                       | 1500/-  |
| 2      | Booking by working as well as retired employee of BSNL for their near relatives.  | 12,000/-                      | 1500/-  |
| 3      | Booking by working as well as retired employees of Postal Department for their use or use by legal dependents   | 12,000/-                      | 1500/-  |
| 4      | Booking for Association and Union of BSNL for their programs.   | 7,000/-                       | 1500/-  |
| 5      | For outsiders ( on recommendation of any working employee of BSNL)  | 30,000/-                      | 2000/-  |


**In addition to above:-**

1. Applicants of all category will also be required to take temporary electric connection of minimum 5 KW per day from PESU, Patna or **deposit electric connection charges of Rs. 4000/- per day at the time of booking in this office. However for any small function like birthday, restricted to hall only electric charges of Rs. 2000/- per day shall be applicable.**
2. All applicants will also be required to deposit an additional refundable security deposit of Rs. 4,000/- for recovery of some damage charge etc (if any) and charges in consumption of electric units beyond 5 KW.
3. In case of booking cancellation of community hall, applicant will intimate before one month of booking date other wise 25 % of booking charge will be deducted.

**Definition of the near relative:-**

Near relative of the family of the working/ retired employees are:- 1.Son 2. Son's wife 3. Daughter 4. Daughter's husband 5. Brother 6. Brothers Wife 7. Sister 8. Sister's husband. The booking shall be allotted for function of themselves or function of their Sons & Daughters only.

A self declaration regarding near relative has to be submitted by the employee. In case if it found wrong at any stage even after the function is over, full rent as fixed for outsider will be recovered from the employee.
